The Position

The Johnson Shoyama Graduate School of Public Policy (JSGS) is recruiting for a **full-time**, **four-year-term faculty position at the rank of Lecturer who specializes in Canadian public policy, public administration, or governance**, starting July 1, 2022. This position will be based at our University of Saskatchewan (USask) campus. If you are interested in becoming part of transformative change at JSGS as we enter into an exciting stage of faculty renewal at our USask campus, we invite you to read on.

With growing program offerings and rising enrolment, JSGS has a need for teaching capacity and is recruiting for a four-year-term Lecturer position who specializes in Canadian public policy, public administration, or governance. The successful candidate will teach six courses per year (18 credit units) across JSGS' academic programs (five graduate programs and several graduate certificates), primarily in the Master of Public Administration (MPA) (in person and online) and Joint Master of Governance and Entrepreneurship in Northern and Indigenous Areas (GENI) programs. The successful candidate will also participate in administrative activities, including meetings and committee work.

The position will focus primarily on teaching courses in Canadian public administration, public policy, and governance. Depending on the successful candidate's expertise, teaching assignments will be focused in one or more of the following areas: statistics/quantitative methods, governance and administration, public policy analysis, political economy, policy innovation, strategic management, and/or ethical leadership and democracy.

The salary band for this position as of the 2021-22 academic year is \$81,678 to \$121,278.

This position includes a comprehensive benefits package which includes a dental, health and extended vision care plan; pension plan, life insurance (compulsory and voluntary), academic long term disability, sick leave, travel insurance, death benefits, an employee assistance program, a professional expense allowance, and a flexible health and wellness spending program.

Candidate Qualities

The successful candidate will have completed or be close to completion of a PhD in an area related to public policy, public administration, governance, economics, or public finance or have a Master's degree in one of those areas combined with extensive governance experience. Evidence of effectiveness in teaching at the university level is required. Knowledge of the topics being taught, along with knowledge of public policy, public administration, and/or governance in the Canadian context, and strong interpersonal and communication skills are required. Experience in online teaching is an asset, as is experience working in the public sector.

The ability to contribute to <u>JSGS's Strategic Plan</u> commitments, to diversify JSGS's subject matter and pedagogical expertise, and to participate in public engagement are strong assets.

Candidates who will attract our attention are high-impact teacher-scholars whose ambitions resonate with the JSGS brand of high-quality graduate education and outstanding interdisciplinary research. We are seeking candidates who will contribute vitality to our school's graduate programming, both in person and online (visit https://www.schoolofpublicpolicy.sk.ca/ for the full listing), and our dynamic academic culture.
