Notes: (1) My second-year courses require major research papers of 3,000 words. Students develop papers based on proposals which I grade and give back with pointers about topic, approach, argument, and bibliography. Essays are graded with comments given to students about literary aspects, logic, use of evidence, and correctness or completeness of information. Rewrites are permitted and are similarly graded.

- (2) My second-year courses in addition require a group research project with a written report and oral presentation to the class. These projects are based on primary information with a stress on research to locate hard-to-find sources. I schedule student mini-conferences outside of lecture hours for the presentations. Groups are given grades and feedback about both the written and oral portions of their work.
- (3) There are in-class discussions about readings throughout the course, as well as periodic in-class assignments, usually to write a short essay. Every student receives a participation grade based on spoken and written participation in class.
- (4) Course evaluations show that students consistently rate my courses and teaching somewhat higher than the departmental average. Many find the workload a little heavy. A frequent comment is that the instructor makes the material interesting.
